- 2. THAT this Honourable Court be pleased to issue a temporally injunction order restraining the 2<sup>nd</sup> and 3<sup>rd</sup> Defendants by themselves, their agents or servants from associating with the 1<sup>st</sup> Defendant purportedly as an official of the Plaintiff, restraining them from recognizing the 1<sup>st</sup> Defendant as a representative of the Plaintiff and or by disbursing any funds or donor support meant to be channeled to the Plaintiff union and or from engaging with the Plaintiff to the exclusion of its Secretary General Omar Faruk Osman as stated in its Trademarks and its President of the Supreme Council Abdi Adan Guled pending the inter parties hearing and determination of this suit.
- 3. THAT costs of this application be in the cause.
